Statement from Gary S. - Nominee for Director of the BOD.

Good morning, everyone.

Some of you may be wondering why this resume isn't coming through the BOD. I wasn't surprised.

I did not receive the Board's recommendation and despite the By Laws, they chose to not present my resume today. What should be a matter of service has become clouded by personal dynamics. When principles before personalities gets set aside, we all feel the impact.

To give you some background: I am the Chair of the Convention Arts & Graphics Committee and I was a BOD Pool member in 2024, I raised respectful concerns about how the Board was interpreting Convention Policies and Pool member rights and responsibilities. When I asked for reconsideration, the Chair ruled against me, and I ultimately resigned as a Pool member in October 2024 after six months of service. I'm not the first to do so under this Chairman – no less than 5 Directors, including 3 office managers, have resigned as a result of the behavior of this Chair and the inaction by Directors on the Board to check the behavior.

Even so, I didn't stop showing up. I continued volunteering at the RSO and have worked with several Board members who supported my nomination. Since 2021, I've been actively involved in service for the Board and around the Office. I even helped train some of the current Directors. I bring decades of professional experience—in business, bookkeeping, web design, and e-commerce—and a long track record in NA service, including two full terms as Chair of the Manhattan Area and my current role as Chair of Convention Arts & Graphics.

I meet every qualification required by the By-Laws and Guidelines. I have 5 years and 3 months clean, I served as a Pool member for 6 months, I served 2 years at the Regional Level and 2 years at the Area level. I have an NA sponsor who has an NA sponsor. I'm already trained in the practices and procedures of the RSO. And, I have the willingness to serve. I was told by a Board member that the Chair is terming out anyway, maybe I should just wait to serve until he's gone. I want to be clear: I'm not here to get a seat on the Board. I'm here to serve this Region.

Still, I understand the importance of unity and the principle of Anonymity in Service. So to avoid further distraction, if it within the RSC policy, I respectfully ask that my resume be held until the September RSC. I can qualify again at that time if you like, and trust that the Areas will decide based on my commitment and capability, not politics or personalities.
